### Part C: Technology Readiness Training (September 28 – October 16)

**New!** Technology readiness training is required as it addresses the technical setup to prepare for online testing in preparation for the ISTEP+ and IREAD-3 assessments. IDOE requires that each school corporation designate an IT staff member to complete technology readiness training. The designated IT person should be the person responsible for coordinating all local technology setup and preparation for the Local Infrastructure Trial, Statewide Readiness Test and online testing. The intended audience for this training is primarily Corporation IT Coordinators (CITCs) and school level technology staff. Corporation Test Coordinators (CTCs) and School Test Coordinators (STCs) also may find this training helpful. ## Part G: Local Infrastructure Trials (November 1 – 10)

**New!** For the 2017-2018 school year, capacity for online testing is assessed through the completion of a Local Infrastructure Trial. In previous years the Statewide Readiness Test helped to determine online capacity. For Spring 2018 online testing, the Statewide Readiness Test is a final readiness check for all schools that are scheduled to test online. Do not wait until the Statewide Readiness Test to try to determine your online testing capacity. All requests to test on paper, with the exception of the Grade 10 Winter Retest, must be made this fall, following completion of a Local Infrastructure Trial. Each school will need to conduct a Local Infrastructure Trial for confirmation that your site has the capacity for online testing, including verification of the following items:

- Your school has adequate capacity
- TestNav 8 is configured correctly
- Devices can successfully run TestNav 8
- Local networks will bear the full load
- Participating staff know what to do for the computer-based assessment

**NOTE:** Schools will need to submit verification that they have completed a Local Infrastructure Trial by November 10, 2017. If, during the trial, you determine that your school does not have the capacity to test online, you will have an opportunity to submit an online testing waiver request between November 1-17 for the Spring 2018 test administrations. Instructions for completing a Local Infrastructure Trial will be included as part of the Technology Readiness Training and the Test Administration Training sessions.

## Part H: Mode Selection and Paper Requests for Spring 2018 Assessments (November 1 – 17)

**New!** Between November 1 and 17, **after you have completed a Local Infrastructure Trial**, you will need to log in to PearsonAccess<sup>next</sup> to verify your contact information and indicate testing modes for the Spring 2018 test administrations. By default, all schools are scheduled to test online. For schools planning to test completely online for all Spring 2018 test administrations, no further action needs to be taken. New for Spring 2018, all corporations and/or schools are expected to test at least two-thirds of their students online for ISTEP+ Part 1 and all students online for ISTEP+ Part 2 and IREAD-3. Corporations and/or schools with technology capacity issues that may prevent them from meeting the online testing expectations must indicate paper/pencil mode by grade on the *Manage Participation* screen in PearsonAccess<sup>next</sup> and submit a Waiver Request Form during the Mode Selection (Paper/Pencil Request) window. Information detailing the online testing waiver request process was disseminated to schools in an IDOE memo on August 21. **Paper/pencil mode selection and waiver requests must be made no later than November 17.** Final determinations for paper/pencil mode approvals will be posted in PearsonAccess<sup>next</sup> on or before January 8.

**NOTE:** For the **Grade 10 Winter Retest**, all schools are scheduled to test online and cannot indicate mode selections in PearsonAccess<sup>next</sup>. Schools with technology capacity issues that may prevent them from testing online must submit a Waiver Request Form during the Paper/Pencil Request Window (September 11-22) in order to be considered for paper/pencil testing. Final determinations for paper/pencil mode approvals will be posted in PearsonAccess<sup>next</sup> on or before October 16

## Part I: ISTEP+ Practice Test Windows

The practice window is a designated period of time in which students and teachers can utilize all of the tools required to prepare for testing. The online practice tests will be available in the PearsonAccess<sup>next</sup> training site. **NOTE:** A downloadable version of the paper-pencil practice test will be available in the IDOE – Test Coordinator Corner webpage. Both the online and paper-pencil practice tests can be used by teachers as an instructional activity with their students.

**New!** Pearson will load sample students and generate test sessions for practice tests. The number of sample students will approximate the number of students submitted on the IDOE-TL. The sessions will be created using the IDOE Session Name that is submitted on the IDOE-TL. Sample data will include student First Name and Accommodation for efficient distribution of test tickets. All other data will be generic or generated randomly.

### Part A: Rejected Test Attempt Cleanup Window

Rejected Student Test Alerts are created when a scanned paper-based student test cannot be matched to a current student record in PearsonAccess<sup>next</sup>. This scenario arises from incorrect hand gridding on the paper test document or from incorrect data being entered into PearsonAccess<sup>next</sup>. Corporation Test Coordinators are responsible for addressing rejected test attempts in the window provided.

### Part B: Undetermined Status School Corporation Cleanup Window

The Undetermined Cleanup Window is an opportunity for schools to review students with Undetermined statuses. Only students that have an Undetermined status resulting from a test not being received can have an undetermined result corrected. Corporations and schools are responsible for researching student test submissions in an Undetermined status and verifying the Undetermined status is accurate. When applicable, corporations and schools will provide resolution to Pearson for the student's test record cleanup.

### Part C: ISTEP+ Reporting Training (August 16 – September 7)

Reporting training will cover information on managing reporting groups, how to access reports, how to navigate reports, as well as the different types of reports and data available. The intended audience for this training is primarily CTCs and corporation level administration staff; however, some school level staff may find this training helpful as well.
