Section 1: Before Testing

Part A: ISTEP+ Grade 10 Experience Items and Practice Test Windows

Experience items will be available August 14, 2018. Experience items help familiarize students and parents with the content and format of online tests. **NOTE:** Experience items are non-secure sample test items accessible via a public web link. This link is available on the PearsonAccess^{next} Home screen under Related Link and on the IDOE Assessment website.

The practice window is a designated period of time in which students and teachers can utilize all of the tools required to prepare for testing. The online practice tests will be available through the PearsonAccess^{next} training site.

Pearson will load sample students and generate test sessions for practice tests. The number of sample students will approximate the number of students submitted for online testing. Sample data will include Student First Name and Accommodation for efficient distribution of test tickets. All other data will be generic or generated randomly. Schools can generate additional sample students and sessions, as needed.

First time testers are required to participate in each content area practice test at least once prior to taking the operational assessment. Students participating in a retest are not required to take the practice test(s) unless the student is participating in a new test mode for the first time (e.g., student previously only took the test on paper and will now test online). Teachers may use the online and paper practice tests instructionally with their students.

Paper practice tests are only available in PDF format—they will not be shipped to schools with the exception of Large Print or Braille practice tests. CTCs must download the paper practice test from the IDOE – Test Coordinator Corner for student with formally documented paper testing accommodations.

Part B: ISTEP+ ECA Retest Practice Test Windows

ECA online practice tests are non-secure sample test items accessible via a public web link. This link is available on the PearsonAccess^{next} Home screen under Related Links and on the IDOE Assessment website.

The practice window is a designated period of time in which students and teachers can utilize all of the tools required to prepare for testing.

The ECA Retest paper practice test is included in the student assessment book.

Students participating in a retest are not required to take the practice test(s) unless the student is participating in a new test mode for the first time (e.g., student previously only took the test on paper and will now test online).

Part C: Technology Readiness Training (August 24 – 30, 2018)

Technology Readiness Training addresses the technical setup to prepare for online testing in preparation for ISTEP+ 2018-2019 assessments. This training covers the technical requirements, setup, and use of TestNav 8 and ProctorCache. IDOE requires that each school corporation designates a Corporation IT Coordinator (CITC) to attend this training. The CITC is responsible for coordinating all local technology setup in preparation for online testing. While the intended audience for this training is primarily CITCs, school level technology staff, CTCs, and STCs may also find this training helpful. Please register for one of the webinars below. Section 2: After Testing

Part A: Rejected Test Attempt Cleanup Window

A Rejected Test Attempt (Student Error) is created when a paper test document cannot be matched to a current student record in PearsonAccess^{next}. This scenario arises from incorrect hand gridding on the paper test document or from incorrect data being entered in PearsonAccess^{next}. CTCs are responsible for addressing Rejected Test Attempts in the window provided for each administration. Unresolved Rejected Test Attempts will result in Undetermined results.

Part B: Undetermined Status Submission Window

The Undetermined Status Submission Window is an opportunity for schools to review students with Undetermined (UND) statuses. Corporations and schools are responsible for researching each student test submission with an Undetermined status and verifying the Undetermined status is accurate. When applicable, corporations and schools will provide resolution to Pearson for the student's test record cleanup. Guidance for resolving Undetermined results can be found in the Online Testing Guide located in the [Indiana ISTEP+ Resource Center](#).

Part C: ISTEP+ Reporting Training (August 22 & 27, 2019)
